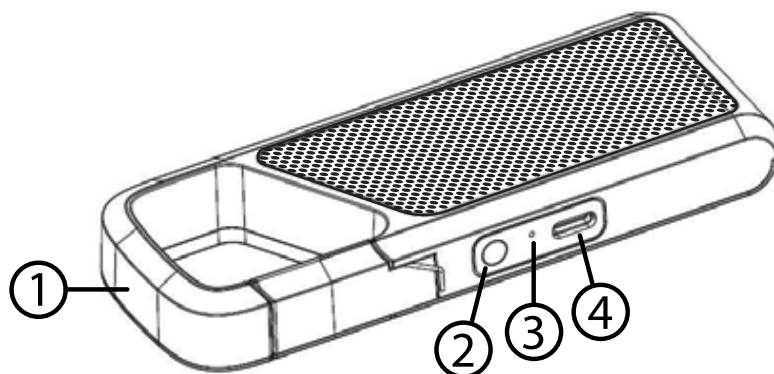
# **Clip Clap 2 Bluetooth® Speaker**

## **Instruction Manual**

---

### **Whats Included:**

- 1 x Clip Clap 2 Bluetooth® Speaker
- 1 x USB to Type-C Charging Cable



## Functions:

---

1. Clip
2. ON/OFF Button
3. LED Indicator
4. Type-C USB Port

## Instructions:

---

*(Be sure to fully charge the speaker before using for the first time)*

### 1. Charging the Speaker:

- Connect the provided Type-C charging cable to a power source and to the Type-C input port(4) on the speaker.
- The LED indicator(3) will glow RED when charging, and will turn OFF when fully charged.
- When the speaker is low on power, a tone will be heard indicating that it needs to be charged.

### 2. Bluetooth® Setup:

- Press and hold ON/OFF Button(2) to turn ON the speaker, LED indicator(3) will flash RED & BLUE when in bluetooth standby mode.
- Turn on the Bluetooth function of the mobile device, Select the "Clip Clap 2" pairing name.

- LED indicator(3) will slowly flash BLUE if successfully paired.
- Speaker will automatically pair if the mobile device has been paired before.
- Press and hold ON/OFF Button(2) to turn off the device.

*\*\* If the speaker isn't connected to Bluetooth it will automatically power off after 3 minutes.*

### 3. Play/Pausing Music:

- Short press the ON/OFF Button(2) to pause or Play music.

### 4. Calling:

- Short press the ON/OFF Button(2) to answer or end the call.
- Long press the ON/OFF Button(2) to reject the call.

## Safety Precautions:

WARNING-When using this product, basic precautions should always be followed:

2. Never store or use this product in temperatures below 32°F(0°C) or above 115°F(45°C).
